

# HoneyWay LLC Giveaway Terms & Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** Giveaway (the “Giveaway”) is open only to those who participate on our live events and who are 18 years of age or older as of the date of entry. The Giveaway is only open to legal residents of the United States and is void where prohibited by law.
